NOW THEREFORE, BE IT RESOLVED BY THE CLINTON CITY COUNCIL that Anna Stanton is hereby appointed as the Clinton City representative to the North Davis Sewer District, which term shall be deemed to commence on January 2, 2020 and shall expire on December 31, 2023, unless superseded by a future appointment.
