MAYOR'S MINUTE

"Go West, young man!" This is a quote many of our ancestors heard back in the 1800's. The Homestead Act of 1862 gave citizens 160 acres. In total, this program gave away about ten percent of all land in the United States. It lasted for 123 years. The last parcel was given away in Alaska in 1986. Unfortunately, I missed the boat, train and wagon for free land.

"Go West, Clinton!" This time the land isn't free nor does the city have money to buy it. However, Clinton has plans to expand west. Our last annexation plan showed Clinton going to the Great Salt Lake. No offense Florida, but we don't want to look like you. There are about 170 acres of unincorporated Davis County west of our existing city boundary near Cranefield Golf Course. Our vision is 4500 West would become the new city line and West Point City would "Go West" from there.

UDOT also thinks "Go West." They already have purchased land for the proposed extension of West Davis Corridor. Clinton will not have the freeway exit, but it will be only a quarter mile away on 1800 N which is located in West Point. The current highway alignment would cut through a small portion of the city. Planners reference land near freeways as transportation corridors. Clinton has never had a freeway, a train, or light rail station. My personal view is that with the new transportation corridor and hopefully newly annexed land, it makes for an ideal location for medium density housing.

Clinton is currently processing an application for a landowner to annex nearly 20 acres into our city. They also own 15 acres that is already our furthest western boundary. In conjunction with the annexation application, they are applying to rezone the land to allow for townhomes. The city council will determine if the RM zone fits that property well, being it is isolated by the slough, canal, drainage channel and future freeway. The zone requires that half of the units must always be owner occupied. Part of their plan is to build a trail along the Hooper Canal that will hopefully someday be expanded north and south with future projects. That trail will connect to the Davis County Drainage Channel that runs east through Clinton. This project would also deed land to the city for a park where the trails connect at the corner of the Howard Slough.

It's interesting to think back that land planning started in Utah over 175 years ago when settlers were "Going West." My guess is the time to "Go West, Clinton" will soon sunset.

We will be holding a public hearing in conjunction with our city council meeting on July 9, 2024 at 6pm. Council members will be discussing the pros and cons of the project's elements and welcome any feedback from the public.

FIREWORK SAFETY TIPS:

Utah State law allows the sales of Class "C" fireworks to be sold June 24th – July 25, December 29 – December 31 and 2 days before and on Chinese New Year's Eve.

Utah State law allows the discharge of fireworks from July 2nd - July 5th and July 22nd – July 25th between the hours of 11 a.m. and 11 p.m. except on July 4th and July 24th the hours are 11 a.m. to Midnight. You can also discharge fireworks on New Year's Eve and Chinese New Year between the hours of 11 a.m. and 1 a.m.

- Purchase fireworks from reliable, licensed fireworks dealers
- Follow all safety guidelines exactly. You must be at least 16 years of age to handle or light fireworks. Adults are to supervise any activity that includes fireworks.
- Adults should never be impaired while engaged in handling, using, placing or lighting fireworks.
- Follow all manufacture recommendations.
- Never shoot fireworks in windy conditions. Keep a bucket of water or running hose nearby during lighting and disposing of fireworks and in case of an emergency.
- Light fireworks one at a time, then move back quickly. Do not re-light or pick up fireworks that have not ignited fully.
- Use caution with animals. Excitement, noise and lights can cause fear and stress.



UTA is updating the Five-Year Service Plan for 2025-2029.
